Dear Commissioners:

Cook Inlet Natural Gas Storage Alaska, LLC ("CINGSA") requests approval of the enclosed amendment to its Firm Storage Service (FSS) Agreement (a "special contract" under Commission regulations) with Chugach Electric Association, Inc ("Chugach").

The tariff filing described below, which includes the enclosed amendment to the FSS Agreement (Attachment A), is transmitted to you for filing in compliance with Sections 3 AAC 48.200 – 3 AAC 48.430 of the Alaska Administrative Code:

Only Appendix A and Paragraph 3 (detailing the effective date) to Chugach's FSS Agreement have been amended. Appendix A specifies the individual customer's contract quantities. This amendment cancels the FSS Agreement between Municipal Light and Power (ML&P) and CINGSA (dated October 17, 2011 filed under TA12-733) and amends the FSS Agreement between Chugach and CINGSA (dated October 17, 2011 filed under TA12-733). Chugach and ML&P have entered into an Asset Purchase and Sale Agreement, dated as of December 28, 2018 and as approved in U-19-020 and U-19-021.

The only change to Amendment A is the combining of ML&P's contracted FSS quantities with Chugach's contracted FSS quantities. Paragraph 3 has been updated to note that billing under the amendment will begin the first day of the month following satisfaction of the conditions precedent.

As this is an amendment to a special contract, it cannot take effect without the prior approval of the Commission. CINGSA respectfully requests that the Commission

approve this filing by the end of the 45-day statutory notice and review period. The amendment provides that it is effective from the first day of the month following Commission approval or January 1, 2021, whichever is later.
